



## Healthy Homes for Seniors Grant Program



### OUR GOALS

- Encourage reinvestment in Springfield's Historic neighborhoods.
- Improve Springfield's housing stock by keeping Senior homeowners in their homes and reducing rental home counts in our select neighborhoods (see neighborhood list at bottom of page).
- Provide accessible housing improvements thus allowing Seniors to be able to age in place.
- Assist Seniors with eligible energy improvements to reduce significant utility price fluctuations for Seniors living on a fixed income.



### HOW IT WORKS

- 1) Senior or family member of the Senior will fill out initial application that can be found on Restore SGF website ([www.restoresgf.com](http://www.restoresgf.com)). Application details the repairs to be made and why those repairs are deemed necessary to improve the Senior's health and well-being in his/her home.
- 2) Once the initial application is approved, the applicant will meet with the Restore SGF Staff, if desired, to go over the project and provide input on the project. The Restore SGF staff can provide a list of preferred contractors.
- 3) The applicant then obtains written bids on all the repairs outlined in the initial application process. After the bids have been collected, the applicant can request another meeting with the staff at Restore SGF to review the bids, to clarify the scope of work and outline the step-by-step process that will be completed.
- 4) Work will be completed by the selected contractor, during the process the applicant is free to contact Restore SGF with any questions or concerns during the rehab process. The Restore SGF staff is available to speak with contractors at any time to clarify any questions the homeowner might have about the work being done or the process. This is to ensure the Senior homeowner that they are not being taken advantage of and that they are getting the repairs they are paying for in the end.
- 5) Once work is 100% completed, and inspected by Restore SGF staff and deemed acceptable, the applicant will apply for reimbursement for 50% of the cost of the repairs or \$4,000, whichever is less. Restore SGF will process this request and issue payment in the form of a check to the applicant within 30 days.

#### EXAMLES OF ELIGIBLE REPAIRS:

- Replacement of doors and windows
- Roof Replacement
- Insulation and caulking, weatherizing existing windows and doors
- Sidewalk/driveway repairs or construction
- Stairs and Railings
- Siding replacement
- Bathroom Improvements and upgrades

- Tub/shower installation.
- Accessibility improvements inside the home, grab bars and mobility assist repairs
- Flooring repairs/replacement
- HVAC repairs or replacement
- Mold mitigation and removal
- Improvements to home to make life a little easier.

## RESTRICTIONS

*Restore SGF has a goal to help those that need it the most. So, there are income restrictions in place for this grant. The grant recipient must have a median household income of 120% or below the median income for Greene County. The chart below shows what household income should be per # of working adults living in the household.*

The borrower may have to provide Restore SGF their most recent federal income tax return along with their most recent 30 days of payroll/income statements.

***You must be able to answer yes to these questions for your improvement to qualify:***

- 1.) YES or NO – Does this repair make my home more energy efficient?***
- 2.) YES or NO – Does this repair help me with accessibility around my home?***
- 3.) YES or NO - Does this repair provide additional safety from natural elements or for home security?***
